## **Thailand Personal Data Protect Act. (PDPA)**

Personal Data Protection Act B.E.2019 (PDPA) is a law to set rules and requirements concerning on collect, use or disclose of personal data to protect the individual privacy, rights and freedoms. PDPA has been officially enforced **on June 1st**, **2022.** 

#### What is personal data under PDPA scope?

Any information relating to a natural individual which able to identify of such person, whether directly or indirectly, but excluded data of deceased person.




