
The European public EV charging sector is increasingly competitive, and monitoring the competition is tough

There are already hundreds of eMobility service providers (eMSPs) and charge point operators (CPOs) in Europe offering public charging, each setting their own tariffs.

These tariffs are notoriously hard to compare. They are disparate, unnormalised, and have a variety of structures that can include subscription fees, energy unit costs, time-based rates, parking fees and overstay charges.


